Bellevue Soccer Club, Inc. Code of Ethics

1. I will encourage good sportsmanship from fellow players and officials at all times.
2. I will remember that all players have talents and weaknesses the same as I do and I will not berate a player, game official or administrator for any reason.
3. I will treat other players, game officials, administrators and fans with respect at all times, regardless of race, sex, creed or abilities and I will expect to be treated accordingly.
4. I will play by the rules at all times.
5. I will at all times control my temper, resisting the temptation to retaliate.
6. I will always exercise self-control.
7. I will provide proof of identification when asked by game official or administrator and realize that if it is unavailable I will not be able to play scheduled game or until identification is provided.
8. Conduct during competition towards play of the game and all officials shall be in accordance with appropriate behavior and in accordance with the rules set by The Bellevue Soccer Club.
9. Illegal drugs and unauthorized prescription drugs shall not be possessed, consumed or distributed before, during or after any game or at any other time at the field and/or complex.
10. I will never place the value of winning before the safety and welfare of all players.
11. I will lead by example, demonstrating fair play and sportsmanship at all times.
12. I will never use abusive or insulting language. I will treat everyone with dignity.
13. I will not tolerate inappropriate behavior, regardless of the situation.
14. I will at all times conduct myself in a positive manner.
15. Players actions on the sidelines during games shall be in the spirit of good sportsmanship at all times. Profanity, profane gestures, arguing, enticing disruptive behavior by spectators and or fans, or any conduct not in the spirit of good sportsmanship, shall require disciplinary action from The Bellevue Soccer Club, Inc. Board of Directors.

Failure to comply may result in the suspension of your privilege to participate in The Bellevue Soccer Club, Inc. Co-Ed league for the following periods:

1st offense suspension from the game and the following game, when it is last game the suspension continues into the next season.

2nd offense suspension from the entire season, reviewed by Bellevue Soccer Club, Inc. Board of Directors.

3rd offense suspension from The Bellevue Soccer Club, Inc. indefinitely.

Note: Any individual charged with a violation of this Code of Ethics shall be afforded the right to appeal any suspension at the next Board meeting of the Bellevue Soccer Club, Inc. All suspensions will be enforced until the Board of Directors have heard the appeal and a final disposition has been made. All monies are non-refundable if found in violation of the Code of Ethics.
